## **Massachusetts Awarded 2016 ESC Energy Stewardship Award**

August 11, 2016: ESC President Tom Walther, presented the first ESC Energy Stewardship Awards to 10 states at the 5th Annual Market Transformation Conference. Awards. Massachusetts was recognized for a combination of the state's leadership, programmatic design, and the amount of private sector investment in guaranteed energy savings performance contracting in the state.

To date, Massachusetts reports private sector investment in energy efficiency through a GESPC in excess of \$865 million.

Dr. Kathleen Hogan, Deputy Assistant Secretary for Energy Efficiency, U.S. Department of Energy, recognized Massachusetts during the 5th Annual ESC Market Transformation Conference for the state's efforts in promoting Guaranteed Energy Savings Performance Contracting.

Dr. Hogan recognized Massachusetts for its partnership in the DOE's ESPC Accelerator Program, and the state's \$350 million pledge toward reaching the Department's \$2 billion goal for public-sector energy efficiency GESPC investments at the state and local level. The \$2 billion goal covers the period from January 2013 to December 2016.

### **What Success Looks Like: Massachusetts-Style . . .**

In April 2016, the Town of Easton entered into a contract for a roof-top solar system at two of its schools. The systems include 2,299 panels, generating approximately \$79,000 in net metering credits in the first year and upwards of \$1.24 million over the 20-year term of the agreement. The total installed capacity of the solar systems is over 700 kW. Annual energy savings for the schools is expected to be nearly 900,000 kWh. The Easton Middle School and Oliver Ames High School solar arrays follow many successful energy efficiency projects in Easton, including the Town's ongoing energy performance contract and associated improvements to municipal and school facilities which is saving \$250,000 in energy costs annually, while improving indoor air quality and comfort conditions in the buildings.
