South Carolina News



Horry County has approved entering a 15-year energy savings performance contract which will save the county more than \$573,000 annually. Upgraded electrical and water systems in more than 100 county buildings will modernize dated county facilities.

An ESPC has commenced at Spartanburg County School District Three. Under the contract, over \$5.5 million of energy efficiency improvements at nine school facilities are guaranteed to save the District more than \$185,000 annually and \$3.5 million over the term, while also addressing critical infrastructure needs.

The South Carolina Energy Office is planning an informational meeting for January to discuss ESPC in the State.

North Carolina News



Appalachian State University has entered into a phase II \$16.3 million comprehensive energy savings performance contract. Energy savings measures will be implemented in 28 buildings that encompasses over 1.6 million square feet. All of the equipment and system improvements will be paid from energy

savings over the 13-year contract term.

The North Carolina ESC Chapter has elected a new Co-Chair, Kevin Overcash (Private Sector). Len Hoey was re-elected as Co-Chair (Public Sector). Other officers elected were Christine (CC) Maurer (Secretary) and Robert Williams (Treasurer).

Indiana News



Work has started on an ESPC project for over 500 housing units operated by Kokomo Housing Authority. The savings in energy consumption from facility upgrades pay for the nearly \$3.4 million dollar project over the term of the contract.

Connecticut News



Tolland has launched a \$10 million 20-year ESPC that is expected to save the city nearly \$600,000 a year in utility and operating expenses across multiple municipal buildings and four public schools. Tolland will receive a \$350,000 utility rebate as part of the project. This is the second project announced under

the state's new Energy Savings Performance Contracting Program.

Colorado News



The City of Montrose is reporting that it has reduced energy costs at nine large facilities by 22 percent (\$90,000) since 2008 through energy savings performance contracting.

Kentucky News



Five years ago, Eastern Kentucky entered into an extensive \$27 million ESPC, the largest such contract in state history at the time. This past fiscal year alone, EKU realized approximately \$3.2 million in utility cost and operational savings at baseline rates (the rates at the time the contract was signed). That figure

jumps to \$4.2 million at current rates. The utility budget for EKU has remained flat during this time period despite the addition of several new campus buildings.

The Kentucky ESC Chapter is providing speakers for an upcoming ADDS Water District meetings on the subject of ESPC for Water and Waste Water Treatment Facilities. The Chapter is also working to provide speakers for the Barren River Area Development District on December 11 and the KIPDA Meeting on January 8th.

Hawaii News



The State's Department of Accounting and General Services is commencing implementation of a \$17.4 million ESPC that is expected to save more than a million dollars in the first year and lower operational costs by \$28 million over the 20 year term. The

scope of this ESPC project will incorporate 22 energy conservation and renewable energy measures across 33 state-owned buildings on the islands of Kauai, Oahu, Molokai, Maui and Hawaii's Big Island.
