The Nevada ESC Chapter will be conducting a special training workshop focused on how performance contracting works for the public sector in Nevada.

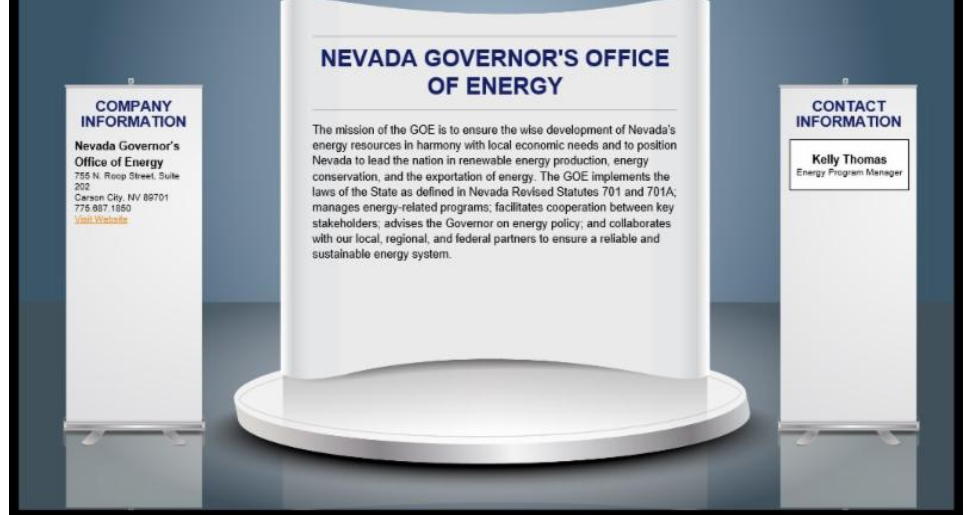

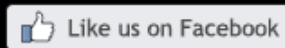
