

Emerging Technologies Session: Solar + Storage and its potential impact on GESPC

October 4 - 2:45 – 3:30 PM

Innovative strategies and technologies are pushing the envelope of what is possible in the way of energy retrofits. This session looks at emerging solar and storage technologies that are pushing building performance to new heights and possibilities.

Chris Halpin, Celtic Energy, moderates the session. Presenters include Anthony Coker, Hannah Solar, and **Jim Bishop, Ameresco**.

Coker will present on The Ray Highway project - a 16-mile stretch of Interstate 85 in southwestern Georgia that is being called the test-run for the roadway of the future: Smart and Sustainable.

Bishop is presenting on the comprehensive GESPC project Ameresco undertook at Parris Island, South Carolina. This project retrofitted 121 buildings (3.1 million square feet total) and will reduce energy consumption by 79% and water consumption by 27% annually. This project also features 6.7 MW of on-site solar photovoltaic generation and a combined heat and power (CHP) system integrated with a battery energy storage
