The 8th Annual ESC Market Transformation Conference kickoffs in Denver with a morning of workshops. One of the two 8am workshops is being put together by the Colorado ESC Chapter with a focus on Guaranteed Energy Savings Performance Contracting in Colorado.

The "Innovative Approaches and Financing Structures to GESPC in Colorado" workshop covers current energy performance contracting practices unique to Colorado and the Rocky Mountain region with presentations ranging from case studies to financing, and the do's and don'ts of project development. Lesson learned are presented including challenges and obstacles clients encountered during the process.

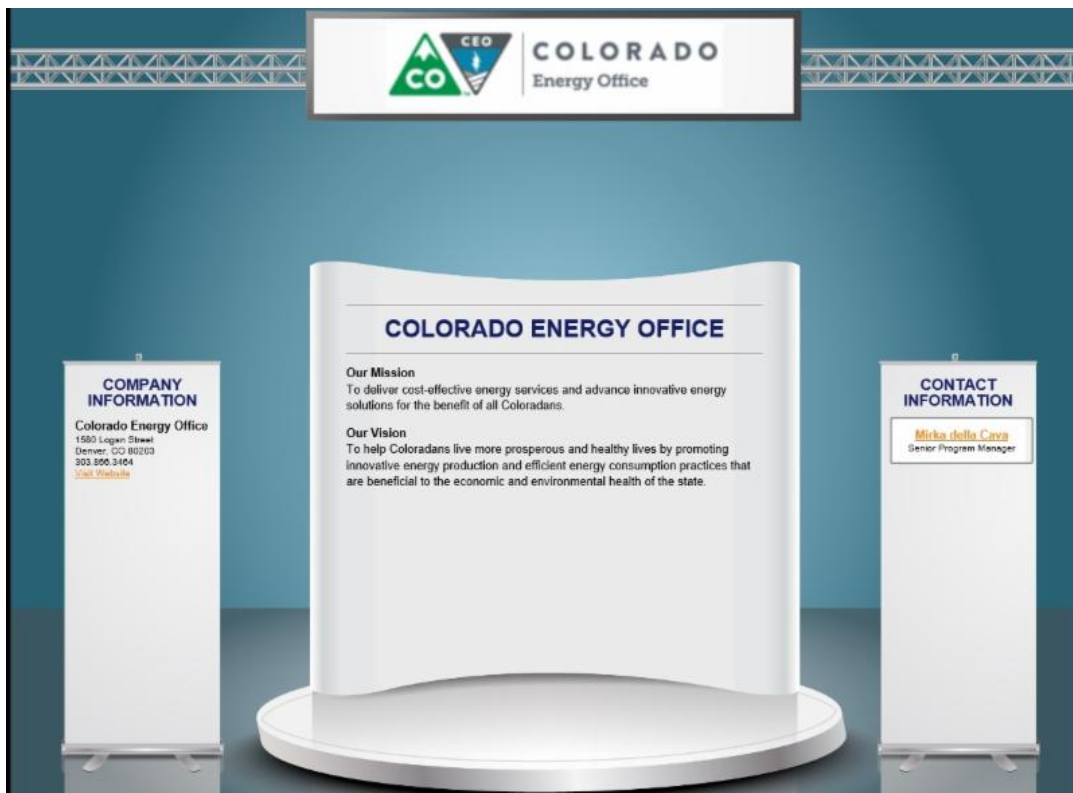

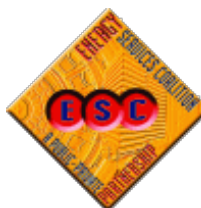
